063.02 Local Development Plan and other issues

MCC should take all opportunities to meet members of the public and one good place would be the monthly Farmers Market. This would offer the opportunity for community councillors to discuss community issues, especially during the forthcoming LDP consultation process. Stand manning could be on a rota basis with a minimum of two councillors present. Queries, complaints or other comments would be recorded on forms provided.

In April 2011 Mumbles Community Council agreed to meet the costs of three schemes: (i) St Peter's Church - £1,460; Overland Road - £1,185 and Norton Road - £1,210. The schemes were going to be advertised together to save costs. Upon a request by C&CS a cheque was sent to C&CS to cover the cost of these schemes upfront.

After a long delay, Alan Ferris (C&CS) consulted the relevant ward members and it became apparent that whilst two of the schemes were uncontroversial, the third, outside St Peter's Church had raised concerns.

Chris Vinestock (Head of Transportation, C&CS) has agreed to cover any additional cost of de-coupling the schemes to allow implementation of the works on Overland Road and Norton Lane as long as MCC confirm they are still willing to fund the scheme at St Peter's Church.

RESOLVED that MCC write to C&CS:

- i. Asking them to proceed immediately with the schemes on Norton Road and Overland Road
- ii. MCC confirm that the funding for St Peter's Church will remain in place and that MCC will meet with all interested parties to try and resolve any differences over the scheme.
