Chairman's Report

 A photographer from the Evening Post took photographs, and Mrs. Cookson was featured in the Evening Post on 2 occasions, but it was very disappointing that the Mumbles Community Council was not given a mention.
- **400.11** Another bouquet of flowers was also sent to Mrs. Irene Alexander to mark the occasion of her 100th birthday, albeit belated.
- **401.11** The Chairman sent a sympathy card from the Mumbles Community Council to the family of Mr Stephen Newbury
- 402.11 Along with other councillors, the Chairman attended the opening of the Oyster Festival, on the evening of the 17th October 2013, which was a great success. The Chairman noted that the Mumbles Community Council was not given any thanks for our contribution to the Mumbles Development Trust. All other contributors were mentioned.
- **403.11** The Chairman attended the Inauguration of Bill Barrington as the new President of the Mumbles and South Gower Branch of the Royal British Legion. The event was held at the Mansion House.
- 404.11 The Chairman attended the Remembrance Day Service, last Sunday, 10th November 2013, held at All Saints Church, Mumbles, and felt honoured to be asked to do a reading at the service, in addition to the laying of the Wreath. She thanked Councillor Tony Colburn, who is the Chairman of the Royal British Legion Branch, for his hard work in organising the event and the splendid buffet that followed.
- 405.11 It is with sadness that the Chairman announced the passing of Mrs. Pat Thomas. Mrs Thomas was for many years the 'lollypop lady' for Mayals School, where she was affectionately known as 'Auntie Pat'. She was awarded the Honour of Mumbles, by the Mumbles Community Council in October 2005, for her long commitment as a lollypop lady

- **410.11 2013/1366 27 Slade Road, Newton OBJECTION -** The visual impact gives an over-bearance to the adjoining properties and the raising of the footings by 1 meter will cause loss of privacy to all surrounding properties.
- **411.11 2013/1478** Land adjacent to 24 Southerndown Avenue, Mayals **OBJECTION** Visual impact on the surrounding area..
- **412.11 2013/1556** The Old House, 2 Slade Road, Newton **OBJECTION** Object to the felling of healthy tree, but would support any lopping that needs to take place, if the C&CS tree officer agrees.
- **413.11 2013/1481** 578 Mumbles Road, Mumbles **OBJECTION** Visual impact on front of property from Mumbles Road. Out of keeping with adjoining properties. Also causing an imbalance to neighbouring properties.
- **414.11 2013/038** Land adjacent to Westwinds, Langland **OBJECTION** Visual impact from Langland Bay. Established tree line in the Langland Conservation Area. Protected by wildlife as in badgers sets and bat habitat. Extra burden on Sewage. Concern over land slippage on such a sleep slope. Visual impact on AONB.

Items from the Highways Committee

446.11 Plunch Lane:-

Double yellow lines, bottom of Plunch Lane.

Cllr. A. Colburn, as CCS, been dealing, and reported that the existing white lines (for pedestrians use) were ineffective. It was not possible to install kerb stones. Double yellow lines under consideration at the moment. (There have been complaints made by residents for improved safety, and arguments been put forward to CCS)

RESOLVED:- MCC request costings for:

- a. Double yellow lines
- b. Coloured tarmac paint

447.11 Castle Road: - Double yellow lines.

Site visit has taken place between Cllr A. Colburn, as CCS, and Alan Ferris, Highways, CCS. Alan Ferris suggested double yellow lines on the Lime Kiln side of Castle Road., opposite the houses, at the narrow point, extending as far as the 20mph sign. C&CS happy to install, but do not have the budget. Cost would be £1500.

RESOLVED that MCC write to the C&CS Councillor asking for a funding contribution

451.11 Local Development Plan

RESOLVED that

- a) That MCC retrospectively approves the communication between MCC and CCS regarding a request for, and agreement to, an extension of time to 20th November 2013 in order to allow Council to consider its formal response to the draft LDP strategy proposals.
- b) That MCC approves the appointment of CDN Planning to provide MCC's strategy response to the LDP strategy proposals.
- c) That MCC opposes the LDP outline strategy proposal for the MCC area which indicates the edge of settlement development should be allowed at Thistle boon and/or West Cross. MCC's rational for its response is contained in the LDP strategy response document distributed prior to the meeting.
- d) That MCC formally submits its proposals for land in CCS ownership surrounding Oystermouth Castle (OY0008), the area of the promenade from Blackpill to the edge of Oystermouth Square, (WC0006) including the built environment of that area as part of its response to the current consultation for the proposed expansion of the Mumbles Conservation Area.
- e) Request full LDP documentation for Oystermouth, Newton, Mayals and West Cross wards from CCS Planning Policy Team which they agreed to provide to MCC on the 7th October 2013 at the Ostreme Centre and which has not been received to date
