- **384.10 2010/1109 -** Land adjacent to 7 Brynau Drive (Plot A), Mayals, Swansea **Objection -** Loss of woodland area with TPO trees. Inpact on wildlife in area. Concerned that no bat or badger survey undertaken.
- **385.10 2010/1301 -** Garages opposite The Hall, William Street, Mumbles **Objection -** Over intensificatgion. Out of keeping. Difficult highway access with party wall concern.
- **386.10 2010/1210 -** 31 Linden Avenue, West Cross **Objection -** Outside the building line. Out of keeping with existing properties
- **387.10 2010/1439 -** Mill Leat, Mill Lane, Blackpill **Objection -** Healthy, mature tree

## 395.10 Christmas Lights

The Clerk, as responsible financial officer, and after taking advice from One Voice Wales, advised the Council of the following figures to be taken into account when making their decision:

The LED lights on Newton Road cost in the region of £7,500 to install. They have been used for 3 years only. The cost of removing these lights together with the ones in Mumbles Road, have been estimated by Phillips electrical at £1,800. Phillips Electrical says that the removed lights would have minimal value. The estimated cost of solving the problem on Newton Road was £900/£1000

#### **RESOLVED** that

- (i) The lights on Newton Road be switched on this Christmas and that the matter be referred back to the Highways Committee
- (ii) The installation of LED lights on Mumbles Road be postponed for Highways Committee to consider further and that the old lights be switched on this Christmas
