Clerk's Report

163.05 Fire Engine

Clerk reported a visit he had in the office from a firefighter who expressed concerns that the small fire engine, the only one practicable for use in many

of the small Mumbles streets, is, during holiday periods used as part of a 'small fire unit' and can be deployed in other parts of the fire region, so effectively leaving Mumbles uncovered.

AGREED that the Clerk would write to Mid & West Wales Fire and Rescue Services asking them for their comment.

164.05 Clerk advised Council that there would be a contested election to fill the vacancy left by Mr Robert Speht.
