# 445.11 Candidates Sites Register

Information published by C&CS and provided in conversations with C&CS officials at public meetings indicates that CCS has changed its published methodology for the determination of candidate sites.

The original programme stated the Stage 2 decisions would be in July 2012. This was then amended to September 2012. Now CCS has apparently decided to combine stages 2 and 3 of the selection process and only provide the final list of selected sites at the time of the issue of the first draft LDP in the spring of 2013. At this same time the preferred LDP Strategic Option will be announced.

The short consultation time early next year will mean that this is likely to be an intensive, time consuming and expensive process for all communities affected.

**RESOLVED** that MCC write to C&CS about the apparent deviation from the published CSR process and requesting clarification on the impact of these changes. This letter to be copied to OVW and all Gower community councils
