295.08 Minutes of the Monthly Meeting held on 10 July 2012

Clerk's Report

- 296.08 The Clerk reported that Mrs Penny Cridge had responded to MCC's letter and that she was "satisfied with the response of the Council". She expressed "thanks to those Council members who agreed for me to present my point of view" and "shall look forward to taking an active interest in (MCC's) future work".
- 297.08 The Clerk advised Council that he had now received a written response from the Information Commissioners Office regarding Cllr Cooper's Freedom of Information Request for a copy of the recording of the June Meeting of Council. The email states that the previous advice was 'rather poor' and 'unfortunately incorrect'. The recording is subject to information requests that can only be denied by using the exemptions in the act. As these did not apply the Clerk advised Council that he had given Cllr Cooper a copy of the recording.
- **298.08** The Clerk advised Council that under Sections 80 and 87 of the Local Government Act 1972 that, once the appeal period expires, Cllr Simon

Arthur will become 'disqualified' as a Councillor for 5 years.
